

Membership Fee Regulations of 1. FC Union Berlin (Resolution of General Assembly from 22.11.2017)

The members meeting of 22 November 2017 adopted the Membership Fee Regulations, which govern all details of the member's obligation to pay fees, according to the club's rules. It is an integral component of the application for membership.

1. Obligation to Contribute

1.1. Members of 1.FC Union Berlin e.V. have to pay an admission fee and monthly membership in accordance with the club's Articles of Association. The amount and due date of admission fee and monthly dues are determined by the General Meeting.

1.2. There are:

- Full Members
- Youth Members
- Family Members
- Honorary Members
- Associate Members
- 1.3 Unemployed persons, pensioners, pupils, trainees, students and people with disabilities are granted a reduction in their membership fee when appropriate evidence is submitted. The proof and each document is to be presented to the club without request. Additional contributions resulting from non-presentation will not be reimbursed.
- 1.4 Unemployed persons, pensioners, pupils (from 13 years old), trainees, students and people with disabilities may also pay their membership fee in the form of charitable work for the club. The Executive Committee of 1.FC Union Berlin e.V. decides on the type and scope of the non-profit work for the club upon application. The provision of membership fees in the form of charitable work for the club is limited to one financial year.
- 1.5. Family members are children up to the age of 12, of whom at least one parent is a full member of the 1st FC Union Berlin e.V..
- 1.6. Honorary members of the club are exempt from the obligation to contribute.



2. Amount of Contributions

2.1. The following membership fees apply from 01.07.2018.

3. Payment / Due Date

- 3.1. The contributions must be paid in advance by SEPA Direct Debit or credit transfer on a monthly, quarterly, semi-annual or annual basis. They will be collected on the due date and/or must be transferred on this date.

- 3.3. For youth members and family members, their legal guardians must agree by signature to pay the membership fee according to section 3.1 of these regulations during the respective valid years of the minor.
- 3.4. Changes to personal data must be communicated in writing to the front office of 1 FC Union Berlin e.V. within ten days.
- 3.5. A processing fee of 5.00 euros will be charged for each reminder.

4. Admittance & Cancellation

4.1. New members must pay a monthly membership fee of one month's fee after confirmation of the membership application. This is collected with the direct debit or must be paid by bank transfer or cash payment.

5. Special Rules

5.1. The Executive Committee may grand a reduction in contributions upon written application during times of financial hardship.

6. Notice of Implementation

6.1. The membership fees detailed above were decided at the General Meeting of 1. FC Union Berlin e.V. on 22.11.2017 and come into force on 01.07.2018. The previous membership fee regulations will be repealed on the same date.
